... not only to put your hand up for positions, but also to help us decide how we can best fill those and other essential functions. At present there are very few people doing a variety of (and in fact too many) functions. Under the U3A By-Laws, as an organisation we must have a President, Vice President, Treasurer, Secretary and we should have at least four other ordinary members. This is not only about sharing the workload, but also to ensure robust discussion of decisions and ideas and a variety of views. At this stage we have only six members on our committee in total (and at times we've been down to five), so the current situation is very concerning. The U3A simply cannot function properly if this continues.

We desperately need new blood to keep U3A functioning - and this is not an exaggeration. A very few people have been doing almost superhuman amounts of work, and this has not been sustainable (either for them or for the organisation). Admittedly, much of this work, in the area of updating record-keeping systems and document templates, has already been completed. Very special thanks in this regard must go to Kath Power and Lou Stevens: they have been doing a wonderful job in updating systems and templates for data input, class attendance sheets, tutor contact and all the other office-prep we need to run our organisation in the future. And Kath is not even a Committee Member!

We have new, exciting classes already begun or beginning shortly (Spanish for Beginners, Italian for Beginners, Computer Starter Course, Art History Stories) and we do not want to close our doors, so we urge you to fill in a Committee nomination form by 4 March or come forward to offer assistance to U3A in other ways. Committee membership means working in the office for at least one morning or afternoon shift, attending Management Committee meetings once a month, and working as a team member so things will run smoothly. A major position to fill will be Treasurer. Our current Treasurer, Sally Gemmell, wishes to resign her position due to health and mobility issues, but will be available to help a new Treasurer with their duties. But you can also volunteer for various roles and not be on the Committee. We envisage that people with certain expertises could volunteer to be called on

infrequently when needs for special services or jobs arise. The positions of Class Coordinator and Office Manager also do not need to be on the committee (but can be).

It would be a terrible situation if we had to close our doors. We know how much our members enjoy the classes, so please notify the office if you can help us out.

VOLUNTEER TREASURER
